



Businesses and nonprofits are increasingly incorporating artificial intelligence to automate routine administrative tasks, analyze data and streamline recruiting. During this session, Ian Kitajima, President of PICHTR and former "tech sherpa" will discuss the different types of AI and how they can help organizations boost productivity. His presentation will also include AI apps that can help individuals generate requests for proposals, take and summarize meeting notes, and create presentations, websites and logos. This session will include a 40-min presentation followed by 20-mins of discussion. We encourage attendees to come to share what they are doing with AI.

While at Oceanit he co-founded 3 venture startups, initiated new areas such as nanotechnology and applied AI, and championed the Design Thinking and computer science movements in public education for over a decade.

He is a Board member for several organizations such as PBS Hawaii, Public Schools of Hawaii Foundation, the Workforce Development Council, University of Hawaii Alumni Association, and the Hawaii Institute for Public Affairs.

Josh Green GOVERNOR STATE OF HAWAI'I

Governor Josh Green is a proud husband, father and physician. For the past 20 years, Governor Green cared for Big Island families as a doctor. He served in the State House of Representatives and the State Senate from 2004 to 2018. As chair of the Senate Health and Human Services Committee, he passed "Luke's Law," which provides care for children with Autism Spectrum Disorder, as well as tobacco and e-cigarette regulations, which increased the legal age for purchasing tobacco and e-cigarettes to 21. Passionate about housing solutions, Governor Green helped create "Kauhale" communities to get unsheltered veterans, kūpuna and others into safe housing options. These efforts are ongoing and will continue to be one of his top priorities as Governor. Governor Green expanded the role of Lieutenant Governor by spearheading the largest healthcare response in state history during the COVID pandemic. These critical emergency efforts resulted in Hawaii having the nation's lowest COVID-19 fatality rate.

Waiohinu is her kulaiwi, Hilo is her onehānau, and she lives in Mākaha with her kāne

Duane DeSoto, on the block he grew up on, with their eight children and one mo'opuna. Pacific Business News has recognized Mālia as a Woman to Watch in 2013, Forty Under 40 Class of 2016, an Industry Leader in 2017, top 25 Women Owned Businesses in 2019, and most recently an awardee for Hawaii'is Fastest 50 in 2020. In addition, Mālia was featured on the cover of *Hawaii Business Magazine*'s 20 For the Next 20 in 2019. Mālia was a Pacific Century Fellow in 2015, Omidyar Fellow in 2017 and Mana Up Fellow in 2019. Ku'ulani was raised on Moloka'i with a deep sense of the interconnectedness of people to place and to one another and that the health of these relationships are integral to living and thriving on an island. She co-founded Maui Nui Venison with her husband, Jake, to balance Axis deer populations on Maui to solve for the unique challenges of this species in Hawai'i, while also channeling that work into nutrientdense food for our communities. She is a firm believer in the power of story and, while raising keiki, turned to writing and illustrative work as modes of storytelling. As Brand Director of Maui Nui, she works to tell its story in continuum with the long-running stories that situate and ground us all in the larger context of place. She, Jake, and three young children, reside in Kahua, Hawaiʻi.



Dr. No'eau Peralto EXECUTIVE DIRECTOR HUI MĀLAMA I KE ALA 'ŪLILI (HUIMAU)

Born and raised in Waiākea Uka, Hilo, Hawai'i, No'eau is a proud descendant of kūpuna from Koholālele, Hāmākua, Hawaiʻi. He is a community builder, educator, cultivator of seeds and stories. and holds a PhD. in Indigenous Politics. He is the founding member, Executive Director, and former president of the Board of Directors of huiMAU. huiMAU is a community nonprofit organization based in Hāmākua Hikina on Hawai'i Island, whose mission is to re-establish the systems that sustain our community through place-based educational initiatives and 'āina-centered practices that cultivate abundance, regenerate responsibilities, and promote collective health and well-being.



Leonani Puailihau SENIOR COMMUNITY RELATIONS MANAGER, TURO

Leonani Puailihau is Turo's Senior community relations manager and a respected leader for her community on O'ahu's west side. She has a deep connection to 'āina and people and has dedicated herself to supporting economic growth, community development, and the advocacy of Hawaiian culture. Leonani has held roles as an educator and program administrator, served as a leader in community relations for different organizations and held board positions on establishments such as Pūnana Leo o Wai'anae, Ka Waihona School Board and Kapolei Community Development Corporation. Organizations and leaders are faced with uncertainty and volatility thanks to the global pandemic, the ever-changing digital landscape, impacts of climate change, social and geopolitical conflicts, and more. This session will explore the concept of Radical Optionality, a new strategic paradigm that allows companies to turn uncertainty from a disruptive threat into a potential source of advantage. Robynne Maii CHEF & OWNER FÊTE




